1.0 Introduction

2.0 Certification Process

Step 1 – Submit the Enquiry Form

Download the Enquiry form from the IIHR website from the below link, fill the details and share the scan copy by email or directly submit to the IIHR branches or with Education Partner of IIHR.

After the submission of enquiry form, candidate will get an email as well as a follow up call from one of our executives for a Face to Face (for Instructor Led Learning Options) or Telephonic Career Counselling (for Self-Study Learning Option / Outstation Students) from Course Director for the admission process.

Step 2 – Pay the Certification Fee

After the counselling session, you may proceed to pay the certification fee as mentioned in the IIHR website. You may opt for the self-study learning option as well as classroom option, based on the feedback received from the course director.

In order to complete the admission process, submit the certification as per the learning options. [Click here to get the Certification Fee](#) for all learning options.

Step 3 –Submit the Application Form

Fill the Application form and submit the same along with the necessary documents as mentioned in the Application form. Once all your requirements (or goals) are met, you will be able to submit your application.

In order to complete the submission of your application, you will need to submit all necessary soft copy documents mentioned in the Application Form by email (for Self-Study Learning) or Submit the Hard Copy documents (for Instructor Led Learning) to IIHR branches.

Step 4 – Choose the Learning Options

If you have selected for the Instructor Led Learning (Classroom Training) options, you can contact the IIHR branches or Education Partner to start the sessions. Training Calendar will be published in the IIHR Mobile App for the Instructor Led / Classroom Learning Options. If you have selected for the Self Study Learning (Distance) options, take your own time for self-learning.

For all the Learning Options, you have one year from the date of admission to apply and appear for your exam for certification. It is your responsibility to ensure you do not let your application lapse. Otherwise, you will have to reapply to take the exam.

Step 5 – Schedule, Take Exam and Get Certified!

You can schedule your exam at any time. We recommend sooner than later to ensure you get your preferred date and time and, so you have a lot of time to take it again if you are not successful on your first attempt. **You can take the exam up to 3 times within your 1-year application period at any time.** Once you've taken it 3 times, you must wait until your application expires, and reapply to take it again.

After the completion exam, your exam handbook will be evaluated, and you will be getting Govt. of India Affiliated as well as Internationally Accredited certifications and mark list.

Step 6 – Job Placement Assistance / Guarantee

We assure job placement guarantee across major cities in India for our Instructor Led (Classroom) weekdays as well as weekend batch students opting for CHRP® and CHRQ® certification programs. We will be giving the Job Placement Guarantee letter to all students at the time of admission. Job Placement Guarantee will be based on the eligibility criteria and as per the Job Guarantee Letter terms and conditions. All the students must agree and follow the Job Guarantee Terms & Conditions.

3.0 Digital Badges

4.0 Appeal Process

If your competency-based assessment (i.e. exam) fails, you have the right to reappear or submit the appeal for re-attempting the assessment by sending an e-mail to director@ihr.edu.in

IIHR will have up to 90 days to review the appeal and make a binding decision regarding the validity of your application. You may be contacted by IIHR for any further information and/or clarification that are deemed necessary to validate information. A final decision will then be emailed to you.

5.0 Suspending or withdrawing certification

IIHR reserves the right to revoke the CHRMTM, CHRG[®], or CHRP[®] certification at any time after review of a reported professional misconduct or for a misuse of the CHRMTM, CHRG[®], or CHRP[®] logo or trademarks.

IIHR also reserves the right to conduct random post-certification audits.

All fees paid shall be forfeited in the event of a revoked or suspended certification. Those certification recipients whose certification has been revoked will not be allowed to reapply for the CHRMTM, CHRG[®], or CHRP[®] for a period of time to be decided at the discretion of IIHR.
